**REGULATION**  
**OF THE MINISTER OF FINANCE AND ECONOMY <sup>1</sup>**

of 23 December 2025

**amending the regulation on the detailed conditions for conducting a tender for entities applying for  
a licence to operate a casino  
or a licence to operate a cash bingo hall**

Pursuant to Article 33(5) of the Act of 19 November 2009 on gambling (Journal of Laws of 2025, item 595), the following is hereby ordered:

**§ 1.** The Regulation of the Minister of Finance of 27 August 2010 on the detailed conditions for conducting a tender for entities applying for a licence to operate a casino or a permit to operate a cash bingo hall (Journal of Laws of 2013, item 1156), the following amendments are introduced:

- 1) in § 1:
  - a) paragraph 1 shall read as follows:

"1. The tender notice for entities applying for a licence to operate a casino, hereinafter referred to as "licence", or a permit to operate a cash bingo hall, hereinafter referred to as "permit", shall be published in the Public Information Bulletin on the website of the office serving the minister responsible for public finance."
  - b) in paragraph 2, point 5, letter e, the full stop shall be replaced by a semicolon and point 6 shall be added, reading as follows:

"6) indication of the manner of submitting bids referred to in § 3(1) and opening bids.";
- 2) in § 2(1)(3a), after the words "submitted tender", the words "during the first three years of conducting this activity" shall be added;
- 3) § 3 shall read as follows:

"§ 3. 1. Entities applying for a concession or permit shall submit bids in the form of:

  - 1) electronic form via the e-Koncesje ICT system;
  - 2) paper form at the office serving the minister responsible for public finance.

2. In the case referred to in paragraph 1(1), the e-Koncesje ICT system shall prevent the contents of the tender from being viewed before the tenders are opened by the tender committee.

3. In the case referred to in paragraph 1(2), the tender shall be sealed and secured in such a way as to prevent its contents from being viewed before the tenders are opened by the tender committee.";

- 4) in § 6:
- a) in section 2, point 2 shall read as follows:  
"2) opens bids submitted within the specified time limit."
  - b) after paragraph 2, paragraphs 2a–2c shall be added, reading as follows:  
"2a. In the case of submitting bids in the manner referred to in § 3(1)(1), information about the bids submitted, including the subject of the tender, the names of the entities that submitted the bids, and the locations of the gaming centres indicated in those bids, shall be posted in the e-Koncesje ICT system on the date of opening the bids.  
2b. In the case of submitting bids in the manner referred to in § 3(1)(2), entities that submitted bids within the specified time limit may be present at the opening of bids.  
2c. Information on the bids submitted, including the subject of the tender, the names of the entities that submitted bids, and the locations of the gaming centres indicated in those bids, shall be published on the day of opening of the bids in the Public Information Bulletin on the website of the office serving the minister responsible for public finance."
  - c) in paragraph 3, point 1(b), after the words "regarding the content", the words "and the method of submission" shall be added;
- 5) in the Annex to the Regulation, in paragraph 3a, in the introduction to the list, after the words "submitted bid", the words "during the first three years of conducting this activity" shall be added.

**§ 2.** Tenders for entities applying for a licence to operate a casino or a permit to operate a cash bingo hall, for which the tender notice was announced before the date of entry into force of this Regulation, shall be subject to the existing provisions.

**§ 3.** Until the launch of the service consisting in the submission of applications and tender offers via the e-Koncesje ICT system for the granting of a concession to operate a casino or a licence to operate a cash bingo hall, as specified in the announcement issued pursuant to Article 27(1)(3) of the Act of 8 June 2022 amending certain acts to automate the handling of certain matters by the National Revenue Administration (Journal of Laws, items 1301 and 2707), the provisions of § 1(2), § 3 and § 6 of the Regulation amended in § 1, in their current wording, shall apply.

**§ 4.** The Regulation shall enter into force 14 days after its publication.
